INVESTMENT STRATEGY

The Fund consists of units from the Fixed Income Fund and Beyond Fossil Fuels Fund. The enhanced global equity index portfolio invests in a broad array of US common stocks, international developed market, and emerging market countries. Both the fixed income and equity components of the Fund avoid investments in companies with the greatest amount of fossil fuel reserves – those that produce or explore for oil, gas or coal. The Fund employs shareholder engagement and, social and environmental screens.

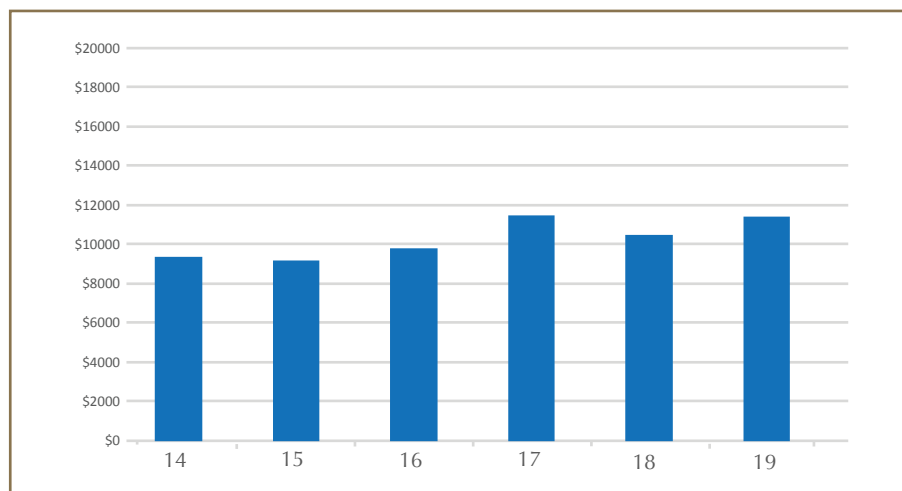

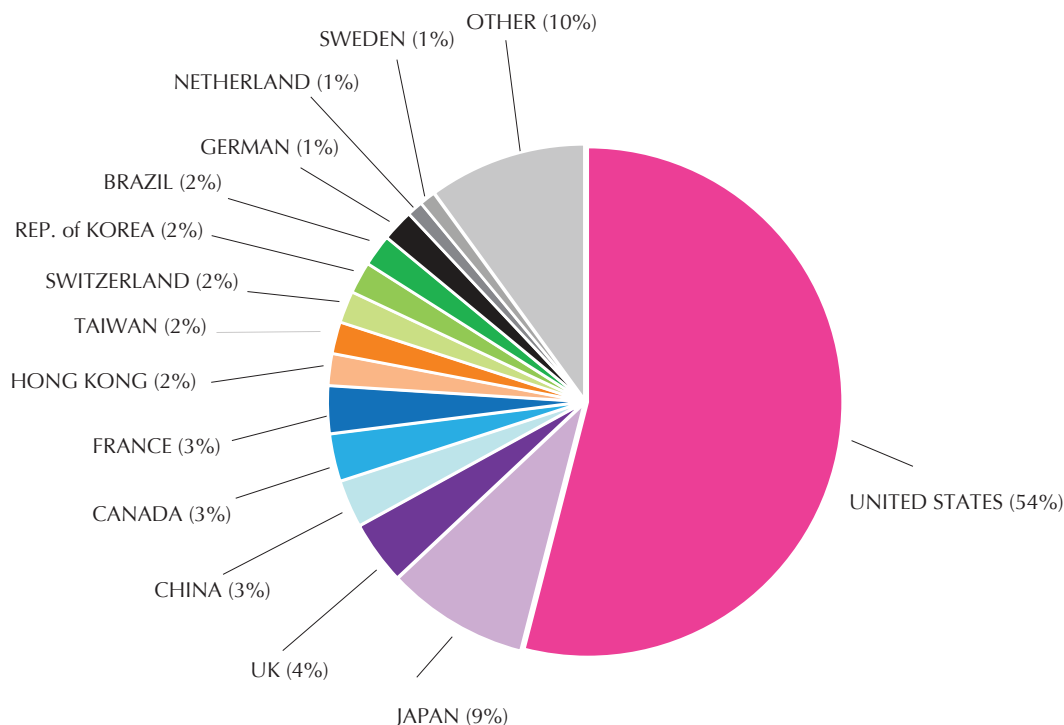
