The Fund employs shareholder engagement and social and environmental screens.

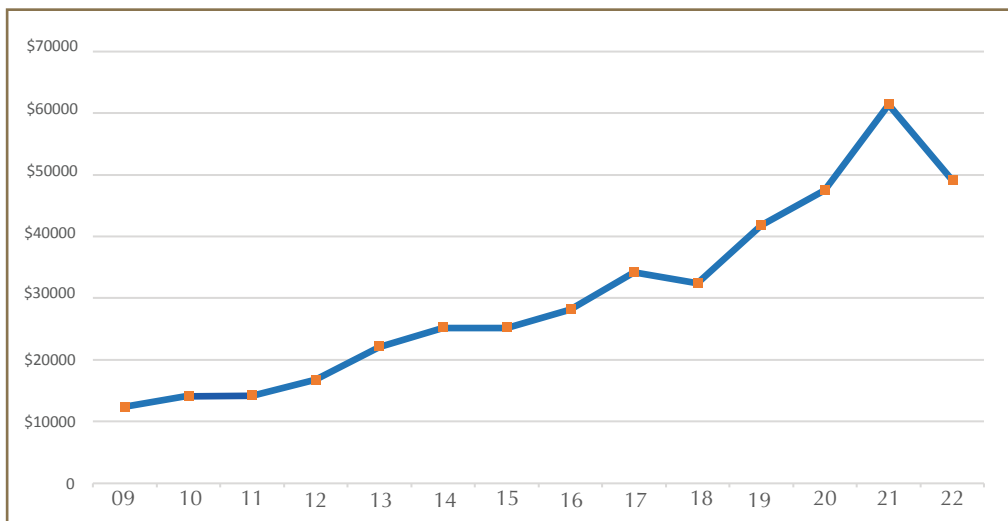

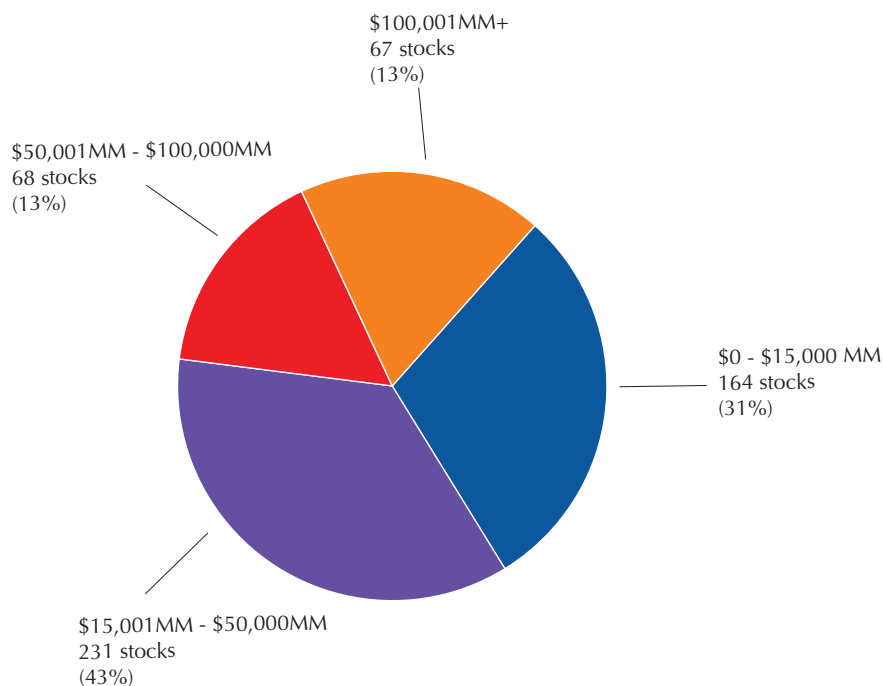
