# **INVESTMENT STRATEGY**

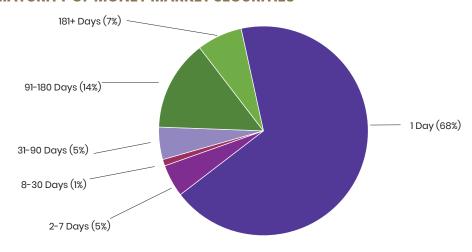

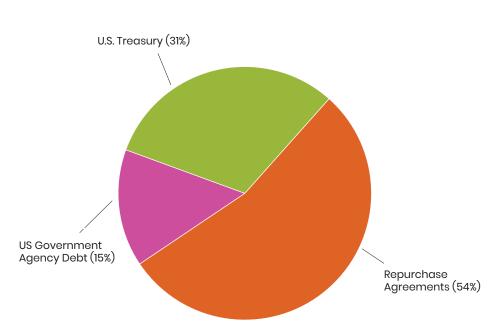

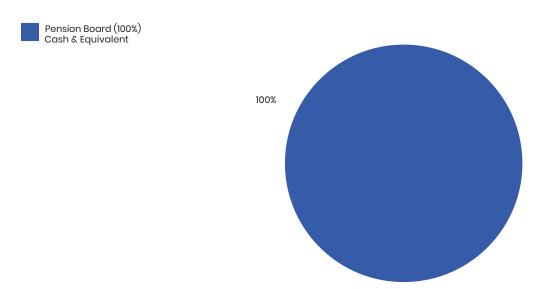
