

# **BEYOND FOSSIL FUELS BALANCED FUND**

#### **FUND OBJECTIVE**

Seeks to provide investors with a total return consistent with a globally diversified equity and fixed income portfolio free of investments in companies that explore for or produce fossil fuels.

#### **INVESTMENT STRATEGY**

The enhanced global equity index portfolio invests in a broad array of U.S. common stocks, international developed markets and emerging market countries. Both the fixed income and equity components of the Fund target a portfolio with reduced carbon emissions intensity relative to benchmark and avoids investments in companies with fossil fuel reserves – those that produce or explore for oil, gas or coal. The Fund employes shareholder engagement and social and environmental screens.


